

INFORMATION ON THE PROCESSING OF PERSONAL DATA AND CONSENT TO PROCESSING OF PERSONAL DATA

Personal data controller:

Scope of processing of the data by the Controller:

Name, surname, maiden name, home address, date of birth, information on current health status, food intolerances, birth registration number, place of birth and information on educational attainment and capturing the likeness through photographs and videos of the participant of **Introductory camp of the 1st year students of bachelor studies at the Faculty of Science**, held from 19 September 2023 to 21 September 2023 (hereinafter the "*Event*").

Legal titles of processing of the data:

Provision of explicit consent within the meaning of Article 6 (1) (a) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (the "*GDPR Regulation*") for capturing the image of the participant of the Event in photographs and videos. Fulfilment of the Controller's legal obligations related to the Event for other personal data listed above.

Processing purposes:

Registration of participants of the Event, ensuring adequate care for the health of participants, protection of the vital interests of data subjects, documentation of the Event, presentation of the Event on the website.

Retention period of the data:

For a period of 10 years from the granting of consent.

Declaration of the Controller:

The Controller hereby declares that they will collect and process personal data to the extent necessary to fulfil the stated purposes and will process it only in accordance with such purposes. Employees of the Controller or other persons (other processors) who process personal data on the basis of a contract with the Controller are obliged to maintain the confidentiality of personal data, even after the termination of the employment relationship or agreed work.

You have the right to:

- request information on what personal data is processed regarding the Event,
- request the deletion of personal data if you consider that there is no longer a reason for processing it,
- request the rectification of personal data if it is invalid or out of date,
- request that your personal data should not be processed until the validity of the above objections has been resolved,
- lodge a complaint with the supervisory authority.
