PROIntensAfrica- historical overview

Early concept note

September 2012, under a joint Cirad – Wageningen UR initiative, representatives of 13 European institutions (CULS included) met to fulfill interest of EU represented by Robert Jan-Smits (DG RTD)- focus on "Article 185".

Meetings in Montpellier, Brussels and Paris during 2013-2014

To work on strategic and conceptual approach to create winning consortium and to share visions for CSA call and to involve partners from Africa.


Proposal submission 6/2014 and Kick-off meeting in Accra 4/2015

Consortium agreed on 7 WP including strategic research agenda creation (WP2) where CULS participate.

During kick- off meeting there has been still not fully shared visions on methodological approach.

CULS involvement- since early phase based on partnership with leading Universities and active participation in AGRINATURA.

Team member

Early involvement allows you to understand motivations of all partners and increases chances to implement your vision and expectations- position of institution matters. Work on proposal needs to have leading institution strong, experienced and effective in administrative processes as Wageningen University did.

Timing

Leaders of WP's lack active participation. Therefore, continuous attention and importance of constant work on objectives is necessary even personal meetings are effective and enjoyable.

Effectiveness

To be able to achieve agreement between many partners (even on only conceptual framework) is complicated and delicate. WP leaders must have clear vision and experienced behaviour to drive other partners in viable and shared conclusions.
